03 Events after the Reporting Period

There have been no material events occurring after the reporting date except for the following that would require adjustments to or disclosure in the Financial Statements.

Super Gains Tax

As announced in interim Budget 2015, the Finance Bill passed in Parliament on 20th October 2015, provides for the imposition of one off tax of 25% on taxable profits for the year of assessment 2013/14 on any company or each company in a group of companies, if the company's / Group's profit before income tax exceeds Rs. 2,000 Mn.

The consolidated profit before tax of the Group and that of the Company exceeds the said threshold of Rs. 2,000Mn. Accordingly, as per the provisions of the bill approved by the parliament liability is estimated Rs. 554,228,650 for the Group and Rs. 438,391,385 for the Company.

Group and Company paid first installment of super gain tax amounting to Rs. 184,742,883 and Rs. 146,130,462 respectively on 30th October 2015.
